

FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN BROWNING FERRIS INDUSTRIES OF OHIO, INC. (BFIO) and WELLINGTON TOWNSHIP, OHIO FOR THE COLLECTION AND DISPOSAL OF SOLID WASTE, RECYCLABLE MATERIAL COLLECTION/PROCESSING, YARD WASTE COLLECTION AND BULK MATERIALS PICK UP ("THE MOU")

THIS FIRST AMENDMENT TO THE MOU (this "First Amendment") is made and entered into to be effective on DECEMBER 17 2024 (the "Effective Date"), by and between BROWNING FERRIS INDUSTRIES OF OHIO, INC. (BFIO) and WELLINGTON TOWNSHIP, OHIO.

RECITALS

- A. BROWNING FERRIS INDUSTRIES OF OHIO, INC. (BFIO) and WELLINGTON TOWNSHIP, OHIO entered into The MOU dated October 10, 2024, for the collection and disposal of solid waste, recyclable material collection/processing, yard waste collection and bulk materials pick up.
- B. BFIO desires to continue providing these services to WELLINGTON TOWNSHIP, OHIO, and the parties desire to enter into this First Amendment to provide pricing for an additional container.
- C. Now, therefore, BFIO AND WELLINGTON TOWNSHIP, OHIO desire to enter into this First Amendment to The MOU.

AGREEMENT

1. This First Amendment shall be effective on DECEMBER 17 2024.
2. Upon request, and if available, one (1) additional 96-gallon Container for Garbage and Rubbish can be provided to a Wellington Township, Ohio resident for an additional charge of \$7.20/month. Charge for delivery of new cart and/or removal of carts is \$50.00 per occurrence.
3. Except as set forth herein, The MOU and Amendments shall remain in full force and effect. In the event of a conflict between the terms of this First Amendment and those contained in The MOU or the Amendment(s), the terms of this First Amendment shall prevail and control.
4. This First Amendment may be executed in one or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

IN WITNESS WHEREOF, BFIO AND WELLINGTON TOWNSHIP, OHIO have caused their respective duly authorized officers to execute this First Amendment as of the date and year first above written.
